



For the past 15 years, Good News TV has been an integral part of the ministry of the Arizona Conference Corporation. Since its inception, the Good News TV ministry has faithfully supported the Arizona Conference Corporation's evangelistic mission. Likewise, the Arizona Conference Corporation has always supported Good News TV's initiatives.

A strong ministry partnership was formed based on mutual support, trust, and close collaboration, developing an emotional bond between the Arizona Conference Corporation and Good News TV. Good News TV is considered a part of the Arizona Conference family. Both Good News TV and the Arizona Conference Corporation envisioned a shared evangelistic mission for the future.

Last year, two entities advised the Arizona Conference Corporation that the current relationship with Good News TV should be revised. The General Conference legal department recommended that Good News TV become a separate legal entity to reduce the church's risk of liability in the event of a lawsuit. The General Conference Auditing Service also recommended a separation due to Good News Broadcasting Network, Inc. being a separate 501(c)3. The collection of offerings and donations through the Arizona Conference Corporation financial system was a financial irregularity.



Although neither entity wanted to separate, the recommendations were carefully considered. After months of in-depth discussions, legal consultations, and many hours of earnest prayer, it was decided to bring this matter to the Arizona Conference Corporation Executive Committee.

The Arizona Conference Corporation greatly values the Good News TV ministry. Certainly, Good News TV broadcasts have increased local church growth, with many viewers becoming active and financially contributing to local churches. While there are advantages and disadvantages to changing the legal relationship, it was determined that it was in the best interest of both entities to begin a process of redefining the legal relationship, while still maintaining our shared evangelistic mission.

Good News TV will not be an "independent ministry."

Rather, it will become a "Supporting Ministry" dedicated to fully supporting the evangelistic mission of the Arizona Conference Corporation as it has always done, regardless of the change in legal structure.

Good News TV's home will remain in Scottsdale, Arizona. It will continue to support the Arizona Conference programs, such as Camp Meeting, Conference Evangelism, and Thunderbird Adventist Academy. Good News TV will also continue to actively promote the local Seventh-day Adventist Churches throughout the Arizona Conference territory on its English and Spanish channels. All of this will remain unchanged.

The most noticeable change will be that your financial support for Good News TV will no longer be given through your local church or the Arizona Conference. Beginning on January 1, 2025, Good News TV and GNTVLatino will no longer be listed on the Church Tithe Envelopes or the Adventist Giving web pages.
